COVID-19 RESPONSE

When COVID-19 hit in early March, we joined non-profits and businesses around the world in revamping how we operated on a daily basis. For us, this meant closing all common areas, not allowing the intake of new guests, and only serving those already with us.

We expanded our services to offer lunch and dinner to ALL families at Beacon Children's Hospital, sometimes serving more than 80 meals per day! See how we adapted to the challenges of COVID with some data below, encompassing March 9 – September 30.

Then, our little elves get to work wrapping all the gifts to make sure the holidays are special. This year, staff and a small team of volunteers took on the role of shoppers, wrappers, and gift-deliverers. Here are the families we were able to help:
